Re: Union Fire Company 319 Milton Ave. Ballston SPA JM EPDM Repair. Repair and coat upper roof. Shingle roof replacement Scope of work include:

- 1.) Repair upper roof metal with cover plates and extended drip. \$1,950.00
- 2.) Power wash upper modified roofing followed by Install 15 year silicone roof coating. \$24,500.00
- 3.) Install metal pans off the modified roof on to the shingle areas. \$3,500.00
- 4.) Remove existing upper and lower shingle roofing followed by install 6ft ice and water new drip and lifetime architectural shingles. \$15,000.00
- 5.) Overlay EPDM rubber roofing on tower \$2,400.00
- 6.) Parapet wall metal rap \$1,280.00
- 7.) Install EPDM and termination on lower ledge . \$1,800.00
- 8.) Repair lower EPDM rubber roofing stripping in all the seams and dressing up the corner flashings.\$9,200.00
- 9.) All work will need to be done with good weather conditions. 3 nice consecutive days of good weather.
- 10.)Prevailing wage has been incorporated into the quote.

Bid excludes any framing and cutting of roof deck.
