² From Mayor Rossi: The only changes made from the Tentative Budget to the (Proposed) Final Budget are the decrease of revenue line A-2706-000-00 by \$2,500 and the increase of revenue line A-0914-000-00 by \$2,500 to account for the shortfall in Saratoga Arts grants awarded to the Committee on the Arts by providing \$2,500 that will be rolling over into the General Fund's Fund Balance after May 31, 2025.
