Trustee Baskin noted that the Park and Tree Board submitted their recommendations for the Birdhouse contract and are looking over the parks law.

The Arts Committee is considering putting a decoration on the new CDTA shelter, Trustee Bakin reported.

Trustee VanDeinse-Perez stated that Saratoga Arts applications are due 11/28.

The Bottle Museum will have a ribbon cutting on 10/6 at 4:30 and will be exhibiting a glass factory mountain that will reflect the history of bottles and mineral waters in Saratoga County.

6) Treasurer's Report

Mayor Rossi shared that it will be time to prepare for relevies soon, statewide sales tax went up 4% and 10% in the State. Also, the AUD is being actively worked on.

# 7) Presentation

a) Department Update: Police Department (Chief David Bush)

Chief Bush announced that the Dept. has been awarded a Criminal Justice Services Grant in the amount of \$9,808.00 for narcotics investigation.

Chief Bush stated that Narcan and Narcan training is available to anyone who wants it.

Additionally, Chief Bush noted that we now have Officer Ackley concentrating on traffic issues 2 days a week.

Chief Bush noted improved communications between law enforcement agencies is in the works.

## 8) Old Business

a) ASCC Birdhouse Contract (Trustee Baskin)

Trustee Baskin said he and the Park and Tree Board have concerns about the contract.

b) Family Fun Day Accounting (Trustee Baskin)

Mayor Rossi shared cost and donation figures for the event, stating that the cost to the Village was \$8,167.97.

Mayor Rossi thanked the Task Force and donors for what they did.

Trustee Baskin thanked the volunteers.

c) Studio A Contract (Trustee Baskin)<sup>1</sup>

Mayor Rossi stated that the contract has been fully executed.

Trustee Baskin gave an overview of how FOIL requests are processed.

Gina Marozzi, 10 Old Glory Lane asked why the Events Task Force is the only group or committee to be scrutinized.

Ray Otten of 16 Middlebrook Avenue asked if anything is being done with the park in Colonial Hills.

Pete Martin, 20 Chesterwood Court chastised Trustee Baskin for the way he talks to women, his demeanor and for being dishonest.

Keith Lewis of 38 East High Street stated he hired an outside social media company to monitor and assess the Mayor's Facebook page and accused the Mayor of hiding comments and not honoring the Constitution.

Trustee Kormos is unhappy with the way FOIL requests are handled.

Lisa Speidel, 106 Prospect Street asked about the status of the fire whistle blowing at noon and 6:00pm.

Mayor Rossi stated he will check, last he heard, it needed to be replaced.

Responding to Mr. Martin, Trustee Baskin said his comments were inaccurate.

Regarding criticism of the Board for being involved with the Ethic's Code that they will have to answer to, Trustee Baskin stated that the Board will make the laws they think are appropriate.

Mayor Rossi thanked the Ethics Board for their work and non-partisanship.
