6) Consent Agenda Items for Consideration

a) Motion made by Trustee Raymond, seconded by Trustee VanDeinse-Perez to approve the items on the following Consent Agenda:

i) Motion that Eagle-Matt Lee Fire Co. #1 be authorized to expend the amount of \$22,895.00 for Plymovent upgrade.

ii) Motion that Eagle-Matt Lee Fire Co. #1 be authorized to expend the amount of \$1,055.74 for 2 structural fire boots.

iii) Motion that SLIC Fiber be authorized to solicit door to door from 10/28/25 through 11/20/25 from 10:00am to 8:00pm.

iv) Motion that the Police Dept. be authorized to expend the amount of \$9,588.00 for equipment for the Dodge Durango.

v) Motion approving emergency work performed for replacement of the BSPD (already performed through emergency authorization) for \$7,200.00.

vi) Motion approving installation of lettering on the new BSPD vehicle by Adirondack Sign Co. LLC for the cost of \$1,500.00

vii) Motion approving purchase of cloud service contract extensions for the Village's 13 radar speed signs, for extensions for all signs to reach December 1, 2028, for a total of \$10,350.00, and authorizing the Mayor to execute the attached agreement.

7) Motions/Resolutions for Consideration/Vote

a) Motion made by Trustee Price-Bush, seconded by Trustee VanDeinse-Perez, approving the purchase of a 2024 Chevrolet Silverado Tarco Dump Truck (Silverado 5500) for the price of \$154,288.00, and approving the financing of the Dump Truck using GM Financial's Muni Lease Option of 5 annual payments for \$34,960.28 (interest rate of 6.662%). This motion authorizes the Mayor to execute any necessary paperwork related to the purchase and/or financing. (Note: The FY2026 Budget included the purchase of such a vehicle.)
