

## LAWN CARE CONTRACT

**THIS AGREEMENT** made this 11th day of April 2022

**BETWEEN** the Village of Ballston Spa, a Municipal Corporation with offices located at 66 Front Street, Ballston Spa, New York, (hereinafter referred to as the “Village”),

**AND** Moe’s Mowing, (hereinafter referred to as the “Contractor”),

NOW for the mutual covenants and conditions contained herein, the parties agree as follows:

1. The Contractor shall for the period May 1, 2022 through October 31, 2022, provide The Village with lawn care services that include, but are not limited to mowing, edge trimming and general law maintenance in the following areas:

3. The Contractor shall receive the sum of \$18,000.00 to be paid in two equal installments on May 30, 2022 and September 1, 2022.
