Mr. Iacolucci supports the Good Cause Eviction Law.

Liz Kormos, 89 Hyde Blvd. also supports the Good Cause Eviction Law.

Regarding Zoning, Ms. Kormos wants it clearly stated in the next draft that PDD's are not allowed.

Trustee VanDeinse-Perez commended the Village Police Dept and the Sheriff's Dept. for their professional work and compassion during a recent incident.

Trustee Price-Bush reported that the Library will be hosting an adult "Downton Abbey tea party on 9/13 at 1:00pm.

On 9/11, there will be a remembrance ceremony in front of Village Hall at 7:00pm.

Trustee Price-Bush noted that open gym is back at BACC every Friday from 6:00pm to 8:00pm. Call 518-885-3261 for info.

Trustee Baskin stated that the Park and Tree Board wanted to thank all who participated in BSpa in Bloom and all who worked to beautify the Village.

Anyone who wishes to plant a tree can reach out to the Park and Tree Board for guidance.

The Committee on the Arts Sounds of Summer had a good turnout. Also, the committee is seeking a new member.

Trustee VanDeinse-Perez shared that there are vegetable planters in Kelley Park, all are welcome to pick some.

Mayor Rossi noted that among other duties, the DPW repaired a sewer main break on Rowland Street, assisted with a valve repair at the County Jail, and winterized the pool among other duties.

# 11) Old Business

## a) Zoning

Trustee Baskin suggested having a common document for the Board to discuss zoning and would also like to schedule another special meeting.

#### b) Fire Contract

Trustee VanDeinse-Perez stated that the Town of Milton proposed a five-year contract at 5%, and that Chief Krogh is confident that will cover all of their needs.

Trustee VanDeinse-Perez said Chief Krogh would like to postpone LOSAP.

Mayor Rossi stated the Town of Milton funds Rock City Falls and a portion of Harmony Corners Fire Departments, but they are not currently willing to fund one for the Village.

Mayor Rossi feels our fire department deserves LOSAP and stated he struggles with the inequity.

Trustee VanDeinse-Perez interjected, saying that we are at an impasse and that is the concern about not accepting the 5% with LOSAP funding.

Mayor Rossi stated it shouldn't be an either/or situation and made a plea to the Town of Milton to stop treating our fire department inequitably.

Trustee Baskin thinks we should sign the agreement as is but agrees our firefighters should be covered by LOSAP.

# 12) New Business

#### a) Good Cause Eviction Laws

Trustee Baskin explained the law and feels the Village should opt in by adopting a law, as it protects both renters and landlords.

Trustee Baskin will provide the Board with more details.

13) Public Comment on Any Issue (3 Minutes)

Ms. Speidel expressed her concern regarding the fox incident.

Liz Biddle of 113 Fairground Avenue shared an experience she and her family encountered with a skunk in their yard during the daytime that was acting weird. Ms. Biddle said the DEC Officers that were at the fair refused to help. Ms. Biddle was able to get help from a Sheriff Deputy who was also at the fair.

Regarding animal concerns, Ms. Kormos thinks it's wrong for the County to only do rabies testing on an animal that has bitten someone.

Ms. Avenarius would like to hear more about Good Cause Eviction.

Rory O'Connor, 199 Milton Avenue spoke about the difficulty of being a landlord, urging the Board to take a good look at the proposed law.

Anna Stanko of 32 Kent Street asked that garbage cans not be left out between pick-ups and asked that the Code Enforcement Officer handle the situation.

Ms. Stanko agrees with Mr. O'Connor regarding the proposed law.

Victoria Rasanan, 795 County Route 68, shared information about wild animal issues.

Paula Sheridan of 881 Alden Avenue in Warrensburg also offered information on wild animals.

Ms. Iacolucci, feels Mayor Rossi should apologize for his Facebook behavior.

14) Other Business (Including, but Not Limited to Board Response to Public Comment)

Regarding the fox incident, Trustee Price-Bush noted that the Police did what they had to do at the time.

Mayor Rossi stated he will never apologize for looking out for the health, safety, and welfare of our residents.
