Liz Kormos of 89 Hyde Blvd. believes the Mayor should recuse himself from choosing a new Ethics Board member.

Trustee Raymond said the homelessness issue is going to get worse as programs get defunded.

Trustee Baskin noted that his neighborhood had a meeting and discussed nonresidential use in the area.

Trustee VanDeinse-Perez noted that some people do not want help.
